## ITUC-Africa Calls for immediate Ceasefire in Sudan and Power Transition to Civilian Rule under the Supervision of the African Union (AU) and United Nations (UN)

The recent outbreak of fighting in Sudan's capital, Khartoum, has caused grave concern among global leaders and organizations. The violence has resulted in numerous deaths and casualties and the destruction of infrastructure. It has profoundly impacted the lives of innocent civilians, including workers, women, youth, and children who have lost their livelihoods.

It is crucial that the rights and welfare of the people of Sudan are safeguarded, and that a transparent and inclusive process is put in place to ensure a peaceful and orderly transition of power.

As a global community, we must unite to support the people of Sudan and work towards a future of peace, stability, and prosperity for all.
